A motion to approve Dilly's Seven Corners Bar Liquor License was made by Dean Konen seconded by Len Heimerman and carried 3-0.

- Dean Konen: Reported road culvert projects on various roads are completed. Tree trimming in Right of Ways is near completion.
- Len Heimerman: No report.
- Cheryl Heller: Reported the County will again hold Private Well testing in the Town, May 2022.
- * Mary Jo Muellenbach: Asked to Cancel TASC as we are no longer using that service. The board gave Mary Jo permission to purchase a Town printer to be used at her home.
- ❖ Ben Henke: Updated the board on the Tractor purchase and sale, the St. Anna Sportsman's holding tank permits and Part time snow plow drivers.
