From Mike Schlaak County Treasurer:

Town of New Holstein residents were assigned approx. \$68,000 less tax levy in 2013 than necessary, causing the mill rate to be approx. 61 cents per thousand less. *As a result, Town residents will be assigned this difference as part of the 2014 tax levy. Therefore the tax rate will likely see an increase of approx. \$1.22 as a result (all other things constant). *This was accidently omitted from newsletter

Winter is coming!

Mailboxes

Town policy states that mailboxes need to be 36" from the edge of the blacktop.

Abiding by this policy will aid our snowplow drivers and will help to ensure your mailbox stays upright when the plows come through.

Ditches

Do not use ditches for stones, dumping, or excess snow removal. Do not enter or exit ditches where there are no existing driveways. Violators will be prosecuted.

Garbage and Recycling

Of all the calls we receive, most have to do with garbage or recycling, here are a few tips and reminders: All of our garbage pick-up is automated, to avoid fly-out, please bag all garbage before putting it in your bin; this will help to keep your property and adjoining properties litter free. All garbage bins and recyclables should be placed at curbside by 6:00 a.m. on the designated pick-up day and removed from curbside within 24 hours. Remember you are responsible for these containers. Garbage is picked up every other Wednesday if you live on or north of Fur Farm Road and every other Thursday if you live on or south of Fur Farm Road.

Items containing Freon; refrigerators, Air conditioners dehumidifiers, etc., will not be accepted but can be taken to Mid-Shores recycling and dropped off for a fee.

Driveways, Culverts and Right of Ways

Driveways and Culverts

Anyone putting in a new driveway or culvert or changing existing ones are required to get a permit from the town before the work has begun. Anyone building a new home or is changing an existing driveway entrance that exits onto a state highway will need a permit from The State of Wisconsin before any work has begun.

Right of Ways

Please remember that tall vegetation and or crops are not to be planted in town road right-of-ways (33 feet in either direction from the centerline). Per town ordinance said vegetation and crops will be removed by the town.

For your protection and that of your family please have your trees trimmed and driveway kept clear so emergency vehicles can easily access your property in the case of an emergency.

Permits

Permits are needed in the township if a remodeling project changes the footprint of the buildings, or makes changes to plumbing, electrical, heating, etc.
