Town Hall 7:00 **June 10th 2015**

The regular monthly meeting for the Town of New Holstein was called to order at 7:00 pm by Chairman, Mike Walsdorf.

Discussed recycling.

Adam Schuh will follow up on the repainting of the town sign.

Bridge posting was discussed and a motion to rescind the posting of the Charlesburg Rd. Bridge as a 20 ton maximum bridge was made by Dean Konen, seconded by Adam Schuh, and carried 3-0.

Discussed Road Superintendents health insurance.

Discussed having an electronic revaluation done vs. an in person revaluation by the assessor next year.

A motion to approve 2 temporary Liquor Licenses for The St. Anna Sportsman's club, one for July 18th 2015 and one for August 23rd 2015, was made by Dean Konen, seconded by Adam Schuh, and carried 3-0.

A motion to approve the list of Operators Licenses as given was made by Adam Schuh, seconded by Dean Konen, and carried 3-0.

Discussed correspondence.

After correspondence, Doug Franzen asked for the floor at which time he announced his resignation. He will give an official letter of resignation to the board.

A motion to adjourn was made at 9:17 pm by Dean Konen, seconded by Adam Schuh, and carried 3-0.
