➤ Right of Ways

Please remember to keep a clearing of 33 feet from the centerline in the road of all obstructions. This includes stones, rocks, vegetation, obstructions, debris, etc. Do not plow snow across roads or use ditches to deposit excess snow. Do not enter or exit ditches/right-a-way where there is no existing driveway.

Please see Ordinance 92-1 for more information.

➤ Vision Triangle

No structure, vehicle, equipment, or object of natural growth, except annually harvested crops, which are not trees, shall be located in a vision clearance triangle. In each quadrant of any public road intersection or road-railroad intersection, there shall be a vision clearance triangle bounded by the road (and/or track) centerlines and a line connecting points on them.

Date: October 18, 2025
Time: 9:00 AM to 12:00 noon

This drop-off is a service for the residents of the Town of New Holstein only. Please be prepared to show proof of residency. Our town employee, Mark Whitten and Supervisor Len Heimerman will be at the drop-off site to aid in unloading your items. Any goods with Freon will not be accepted unless properly tagged. Tires and electronics will also not be accepted.

Recycling is the process of converting waste materials into reusable objects to prevent pollution on land and in oceans.

Some Facts:

- On average each one of us produces 4.4 pounds of solid waste each day.
- Over 24 trillion Styrofoam coffee cups are thrown away each year.
- The amount of wood & paper we throw away is enough to heat 50,000,000 homes for 20 years.
- If all our newspaper was recycled we could save 250,000,000 trees each year.
- Plastic bags and garbage that are thrown away into the ocean have devastating effects on sea animals.
- 24 trees are cut down to make 1 ton of paper.
- In the US we use 2,500,000 plastic bottles every hour.
- There is no limit to the amount of times a can made from aluminum can be recycled.
- We generate 21.5 million tons of food waste each year.
