Town Hall 7:10 November 11th 2020

The regular monthly meeting for the Town of New Holstein was called to order at 7:10 pm by Chairman, Gary Winkler.

Members present: Gary Winkler, Dean Konen, Ben Henke, Mary Jo Muellenbach, and Cheryl Heller, also present were Len Heimerman, Ron, Trevor and Noah Mott, Nick Brownson, and Dale Behnke and Kelly Denzel with Rural Insurance.

The pledge of Allegiance was said by all.

A motion to accept the agenda with the addition to discuss and act on hazard pay for election workers was made by Ben Henke seconded by Dean Konen and carried 3-0.

A motion to accept the minutes as read, from the Oct 7th, 2020 Town Board meeting was made by Dean Konen seconded by Ben Henke and carried 3-0. A motion to accept the minutes as read, from the Oct 21st, 2020 Preliminary Budget Meeting was made by Ben Henke seconded by Dean Konen and carried 3-0.

A motion to approve the monthly treasurers' report as presented was made by Ben Henke seconded by Dean Konen and carried 3-0.

A motion to accept the October bills for payment, and to include payment for the October credit card bill, was made by Ben Henke seconded by Dean Konen, carried 3-0.

Road Supervisors report: Nick stated there are warranty issues with the new tractor that have been repaired; he also stated Truck 1 will need a new oil pan.

Dale Behnke and Kelly Denzel discussed our upcoming policy and pointed out some additions to consider.

A motion was made by Dean Konen to approve the garbage collection rates for assessment at \$82.36 for a small bin, \$123.54 for medium, and \$164.72 for large. Recycle bins will be \$28.73; it was seconded by Ben Henke and carried 3-0.

A motion to pay the election workers hazard pay for the Nov. election, using Routes to Recovery Grant money was made by Ben Henke seconded by Dean Konen and carried 2-0. Gary Winkler abstained.

Dean Konen: Reported on a request to remove a culvert

Ben Henke: Issued two raze permits, and discussed new tractor repairs.

Cheryl Heller: Reported on the outstanding job her poll workers did, amidst a pandemic and record turnout.

Mary Jo Muellenbach: Reported on special assessments and a resident who wants his bins taken off the tax rolls, as he has a dumpster he pays for.

Gary Winkler: Discussed planning and zoning, and the plumbers report on the leak in the ladies room.
