A motion to approve to replace two culverts on Foundry Rd. and culverts on Thede Rd, City View Rd and Irish Rd. not to exceed \$80,000.00 was made by Dean Konen seconded by Ben Henke and carried 3-0.

A motion by Dean Konen to stripe and centerline approx. 7 miles of road not to exceed \$4000.00 was seconded by Ben Henke and carried 3-0.

Discussed garbage issues from various town residents.

A motion to send ordinances for ATV & UTV's, Class B roads, and manure to an attorney for final approval was made by Dean Konen seconded by Ben Henke and carried 3-0.

Cheryl said she will take over website duties, Gary and Cheryl will get together to make the transition, Gary will keep updating in the meantime.

Ben Henke: Diamond mower is almost complete with the tractor, and it should be back early May. The roof on the salt shed is bad; Ben is getting estimates for a steel roof.
