A motion to accept the agenda was made by Dean Konen seconded by Len Heimerman and carried 3-0.

A motion to accept the minutes as read, from the May 12th, 2021 Town Board meeting was made by Len Heimerman seconded by Ben Henke and carried 3-0.

Chris and Kelly Collin presented plans for a Wedding Venue & Farm Market on their property. The board had no objections, and wishes them well.

A motion to approve the monthly treasurers' report as presented was made by Ben Henke seconded by Dean Konen and carried 3-0.

A motion to accept the June bills for payment, was made by Len Heimerman seconded by Ben Henke, carried 3-0.

A motion to enact the Class B Road Ordinance #2021-1 was made by Len Heimerman, seconded by Ben Henke and carried 3-0.

A motion to enact the ATV-UTV Ordinance #2021-3 was made by Dean Konen, seconded by Len Heimerman and carried 3-0.

A motion to enact the Manure Distribution Ordinance #2021-2 was made by Ben Henke and seconded by Len Heimerman after discussion, the motion was rescinded and tabled until July.

A motion to increase the \$ 80,000 culvert repair motion from April 2021, due to a substantial increase in material cost, not to exceed \$110,000 total was made by Dean Konen, seconded by Len Heimerman and carried 3-0.

A motion by Ben Henke to approve Liquor Licenses for The Outdoors, Schwarz's Supper Club, and Seven Corners Bar & grill was seconded by Dean Konen and carried 3-0.

A motion to purchase forks for the MXM100 not to exceed \$650 was made by Ben Henke, seconded by Len Heimerman, and carried 3-0.

Dean Konen: Reported first round grass cutting was done. Dean will look into tree trimming where branches pose possible roadway issues.

Len Heimerman: Reported the salt shed roof should be able to be repaired and not replaced. Len also reported the oil and grease were purchased from the lowest bidder after 3 quotes were received. He also reported repair parts were ordered for Truck #1.

Cheryl Heller: Shared annexation paperwork received from the City of New Holstein.

Mary Jo Muellenbach: Reported on the ongoing garbage & recycling concerns.

Ben Henke: Discussed building permits and shared the planning and zoning reports from the County.
