A motion to contract altitude roofing to install gutters and downspouts along the North side of the building not to exceed \$7,500.00 and to be completed no later than 12-31-19 was made by Dean Konen seconded by Ben Henke and carried 3-0.

Ben Henke: Excavation on the North side will be put on hold until after gutters are installed, He will talk to excavator.
