Driveways and Culverts

Anyone putting in a new driveway or culvert or changing existing ones are required to get a permit from the town before the work has begun. Anyone building a new home or changing an existing driveway entrance that exits onto a state highway will need a permit from The State of Wisconsin before any work has begun.

Right of Ways

Please remember that tall vegetation and or crops are not to be planted in town road right-of-ways (33 feet in either direction from the centerline). Per town ordinance said vegetation and crops will be removed by the town.

Permits

Permits are needed in the township if a remodeling project changes the footprint of the buildings, or makes changes to plumbing, electrical, heating, etc.

Mailboxes

Town policy states that mailboxes need to be 36" from the edge of the blacktop.

Abiding by this policy will aid our snowplow drivers and will help to ensure your mailbox stays upright when the plows come through.

Ditches

Do not use ditches for stones, dumping, or excess snow removal. Do not enter or exit ditches where there are no existing driveways. ***Violators will be prosecuted.***

*For your protection and that of your family please have your trees trimmed and driveway kept clear so emergency vehicles can easily access your property in the case of an emergency.

Town of New Holstein – Fall 2015 Recycling Newsletter

Once again we will be conducting our large item drop off.

Date: October 17, 2015

Time: 10:00 AM to noon

Location: New Holstein Town Hall & Garage

No electronics, goods with Freon, chemicals, paints, oils or tires will be accepted.

As in the past, only Town of New Holstein residents will be allowed to drop off. It's your tax dollars that pay for this service, so please do not bring in items from family or friends located outside of our township. There will be an attendant at the drop off site to aid in the separation of recyclable items vs. large item garbage.

There are going to be some changes in the way we will continue recycling in our township. Up until now we have been participating in dual stream recycling. This meant separating the plastic, metals and glass from the cardboard and paper products. If all goes as planned, we will be switching to single stream recycling. In the near future (hopefully November of this year) you will be receiving a large bin. It will look similar to your garbage bin, but the bin will have a blue cover. This bin is to be used for all recycling items. Plastic, glass, tin, aluminum, bi-metals, paper, newsprint and all types of cardboard can be co-mingled in the bin. You will no longer put any items in plastic bags. Because we are going to this new system, we will be able to recycle a larger amount of items. When the bins are delivered, there will be a detailed letter of explanation taped to the inside cover of the recycling bin.

As with the garbage bins, Advance Disposal will own the bins. The town will be renting them at \$18.00 per year per bin. Advance Disposal will maintain, repair or replace them as needed at no cost to the resident as long as the damage was due to normal wear and tear. If the bin is damaged due to your negligence, then the replacement cost of \$100.00 will be assessed to you.

Recycling days are still once a month and are listed on the enclosed card. Place your recycling bin on the same side of the road as you do your garbage bin. If you have any questions or concerns, you may contact me in the evening at (920)898-5682.
